

MINUTES of a regular public meeting of the Board of Education of School District Number 37, Cook County, Illinois, held in the Joseph M. Porto Community Room at the Marie Murphy School Building, 2921 Illinois Road, Wilmette, Illinois, in said School District at 6:30 o'clock P.M., on the 25th day of January, 2018.

The President called the meeting to order and directed the Secretary to call the roll.

Upon the roll being called, Rick Zelinsky, the President, and the following members were physically present at said location: Louise Dechovitz, Vice President, Dan Garbis, Gil Gibori, Joel Raynes, Sheryl Swibel and Jamie Taylor.

The following members were allowed by a majority of the members of the Board of Education in accordance with and to the extent allowed by rules adopted by the Board of Education to attend the meeting by video or audio conference: N/A

No member was not permitted to attend the meeting by video or audio conference.

The following members were absent and did not participate in the meeting in any manner or to any extent whatsoever: N/A

The President announced that the District has developed a list of capital projects for which it reasonably expects to reimburse itself for the expenditures related thereto with the proceeds of an obligation and that the Board of Education would consider the adoption of a resolution expressing its official intent with regard to such expenditures.

Whereupon Member Jamie Taylor presented and read by title a resolution as follows, a copy of which was provided to each member of the Board of Education prior to said meeting and to everyone in attendance at said meeting who requested a copy:



RESOLUTION Expressing Official Intent Regarding Certain Capital Expenditures To Be Reimbursed From Proceeds Of An Obligation To Be Issued By School District Number 37, Cook County, Illinois.

WHEREAS, the Board of Education (the “*Board*”) of School District Number 37, Cook County, Illinois (the “*District*”), has developed a list of capital projects described in *Exhibit A* hereto (the “*Projects*”); and

WHEREAS, all or a portion of the expenditures relating to the Projects (the “*Expenditures*”) (i) have been paid within the 60 days prior to the passage of this Resolution or (ii) will be paid on or after the passage of this Resolution; and

WHEREAS, the District reasonably expects to reimburse itself for the Expenditures with the proceeds of an obligation:

NOW, THEREFORE, Be It and It Is Hereby Resolved by the Board of Education of School District Number 37, Cook County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Intent to Reimburse. The District reasonably expects to reimburse the Expenditures with proceeds of an obligation.


Section 3. Maximum Amount. The maximum principal amount of the obligation expected to be issued for the Projects is \$7,600,000.

Section 4. Ratification. All actions of the officers, agents and employees of the District that are in conformity with the purposes and intent of this Resolution, whether taken before or after the adoption hereof, are hereby ratified, confirmed and approved.

Section 5. Severability. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.

Section 6. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this Resolution shall be in full force and effect forthwith upon its adoption.

EXHIBIT A

DESCRIPTION OF CAPITAL PROJECTS

After a full discussion thereof, the President directed that the roll be called for a vote upon the motion to adopt said resolution.


