1. Background and Narrative of Budget Reductions:

The district has increased current fees and added extracurricular fees beginning in FY 20. The district is negotiating outdoor field rental with area groups. Programs and services in the Ed, O&M and Transp Funds are under review to look for opportunities to reduce costs.

2. Assumptions Used in the Deficit Reduction Plan:

In general, revenue assumptions are conservative and reflect our new fee structure. Expenditures primarily reflect historical spending that comes in 1.5-2.0% less than budget. We will reduce costs to balance the budget.

- EBF and Estimated New Tier Funding:

We assume the EBF funding will remain the same.

- Equal Assessed Valuation and Tax Rates:

2.0-2.4% annual increase for CPI and new growth.

- Employee Salaries and Benefits:

Individual salary increases are 2.75-6%. Benefit increases average 3.5%. We will be negotiating a teacher contract in the summer of 2020.

- Short and Long Term Borrowing:

No additional borrowing anticipated.

- Educational Impact:

We are looking for ways to more efficiently meet the needs of our students without diminishing the high quality of education provided.

- Other Assumptions:

State and federal funding stays the same. There is no property tax freeze or pension shift.

- Has the district considered shared services or outsourcing (Ex: Transportation, Insurance) If yes please explain:

Yes, we are in insurance, utility and special ed cooperatives. We outsource night cleaning, food service and network services.
