1. Background and Narrative of Budget Reductions:

For FY 21, there is a lot of uncertainty in the budget. Additional COVID-19 expenditures of at least \$150,000 are included in the budget. Local fee revenues and expenditures will fluctuate depending on if we have instruction onsite or remote. We are currently negotiating a teachers' contract so all teacher salaries are estimates.

In other years, we continue to implement our new fee structure, try to expand our field rentals and review expenditures/operations to find savings. The board will evaluate options to balance the budget which include but are not limited to budget reductions and a tax rate referendum.

2. Assumptions Used in the Deficit Reduction Plan:

Revenues are conservative and reflect the current uncertainty in terms of property tax revenues and state funding. Expenditures are consistent with our current staffing level to meet student needs. The district will be working on a new strategic plan during FY 21 where deficit spending will be addressed.

- EBF and Estimated New Tier Funding:

We assume the EBF funding will remain the same for FY 21 and reduced for FY 22, 23 and 24.

- Equal Assessed Valuation and Tax Rates:

CPI will be 0.0% or there will be a property tax freeze for FY 22, 23 and 24.

- Employee Salaries and Benefits:

Individual salary increases are 0.0%-6%. Benefit increases average 5%. We are currently negotiating a new teacher contract.

- Short and Long Term Borrowing:

No additional borrowing anticipated.

- Educational Impact:

We are looking for ways to more efficiently meet the needs of our students without diminishing the high quality of education provided.

- Other Assumptions:

Property tax revenue is the same for FY 21, 22, 23 and 24. The district will receive 2 quarterly payments in FY 21, 3 quarterly payments in FY 22 and 4 quarterly payments in FY 23 and 24 from the state. EBF fundiing reduced in FY 22, 23 and 24. Federal revenues in general remain the same.

- Has the district considered shared services or outsourcing (Ex: Transportation, Insurance) If yes please explain:

Yes, we are in insurance, utility and special ed cooperatives. We outsource night cleaning, food service and network services.
